In order to monitor the performance of our site we collect the following information:

- An IP address to monitor site traffic and volume

- Name of Customer

In order to provide a valuable service to our Members we collect the following details:

- Name
- Address
- Email Address
- Buying Preferences to aid navigation and inform them of offers if they so request

## **COLLECTION AND USE OF PERSONAL INFORMATION**

Personal information is information that can be used to directly or indirectly identify you. Personal information also includes anonymous information that is linked to information that can be used to directly or indirectly identify you. Personal information does not include information that has been irreversibly anonymized or aggregated so that it can no longer enable us, whether in combination with other information or otherwise, to identify you.

Here is a description of the types of personal information we may collect and how we may use it:

# What Personal Information We Collect

Depending on the products and services you use, we collect different kinds of personal information from or about you.

- Information you provide: We collect the personal information you provide—such as your name, username, or email address—when you use our products and services, create an account, Contact Us, participate in our competitions, apply for employment, interact with us at in-person events, or otherwise interact with us.

#### Security:

When you place orders or access your account information, we use a secure server. The secure server software (SSL) encrypts all information you input before it is sent to us. Furthermore, as required by the UK Data Protection Legislation, we follow strict security procedures in the storage and disclosure of information which you have given us, to prevent unauthorised access. Our security procedures mean that we may occasionally request proof of identity before we are able to disclose sensitive information to you.

## **COOKIES AND SIMILAR TECHNOLOGIES**

We use cookies and similar technologies to provide, protect, and improve our products and services, such as by personalizing content, offering and measuring advertisements, understanding user behaviour, and providing a safer experience.

There are instances where applicable laws or regulatory requirements allow or require us to refuse to provide or delete some or all of the personal information that we maintain.

You may Contact Us to exercise your rights. We will respond to your request in a reasonable timeframe, and in any event in less than 30 days.

# INFORMATION SECURITY, INTEGRITY, AND RETENTION
